**RE: ACCESS TO INFORMATION REQUEST UNDER ARTICLE 35 OF THE
CONSTITUTION AND THE ACCESS TO INFORMATION ACT 2016**

As provided for by the above mentioned laws I request comprehensive information on all roads built by the government of Kenya from January 2013 to December 2017. The information should include, but not limited to, the following:

- The name and number of each road
 - The government agency overseeing each road construction project
 - The start date and end date of each road construction project, and the expected end date of the project if not yet completed.
 - The starting location and ending location of each road construction project
 - The length, in kilometres, of every road construction project
 - The cost, in Kenya Shillings of every road construction project
 - The contractor for each road construction project, or contractors where more than one has been contracted
 - The funding source for each road project
- The total length of existing roads in Kenya, including by type

Please note that I have been advised by the Kenya Roads Board to make this request to you after having filed the original request with the Board, whose response dated 4 May 2018 is enclosed.

I would like to collect this information both in paper and electronic format and will collect it physically from the Roads Board. I undertake to pay for any costs incurred during the reproduction of the information.

I request that you make the information available as soon as possible, but not later than 21 days from the date of receipt of this application, as stipulated by Section 9 of the Access to Information Act 2016.
